Information for Applicants Yukon Law Foundation Scholarship Application for Students

The Yukon Law Foundation provides approximately \$15,000 annually for scholarships for Yukon students attending law or law related studies. Disbursement of scholarships is dependent on the applications received and actual funding available.

The criteria for such scholarships are:

- (1) Academic achievement;
- (2) Residency;
- (3) Community involvement; and
- (4) Financial need.

If you meet these requirements, a scholarship may be paid directly to you or the institution you will be attending. Failure to include any of the required documentation or information may result in the immediate dismissal of your application.

Please contact the Law Foundation Office at (867) 667-7500 to obtain an application form or to obtain the deadline date for the current year. The application form is also available on our website at www.yukonlawfoundation.com.

The deadline to submit your scholarship application is August 31 annually. Applications can be sent by mail to Box 31789, Whitehorse, Yukon Y1A 6L3 or dropped off at Suite 304-104 Elliott Street (Dakwakada Bldg.), Whitehorse, Yukon. (The Law Foundation has a drop box at the Law Society of the Yukon office).

Please provide **SIX COPIES OF YOUR COMPLETED APPLICATION ALONG WITH THE ORIGINAL**. If possible, please also e-mail an electronic copy to execdir@yukonlawfoundation.com. Your application must include all the required information, attachments, letters of reference, etc. If documents are missing from your application, you will not be contacted and your application will not be submitted to the Board for consideration.

PLEASE NOTE: The Yukon Law Foundation Board requires students who are awarded scholarships to sign a Return and Repayment Agreement (Letter of Understanding). This agreement requires students who do not return to the Yukon to work for at least a two-year period to repay the scholarship money issued to them.
